APPENDIX Y

CITI Export Control Training Module Instructions

Competition of CITI's "Introduction to Export Control Module" is required for User access to IBM's System.

- 1. Go to https://about.citiprogram.org/en/homepage/.
- 2. Log in if you already have a URI CITI program training account. If not, go to "Register" and complete items a-d below. If

you are already registered in CITI, then skip to 3.

- a. To register, type in University of Rhode Island in the Organization Affiliation box.
- b. Review Terms of Service and Privacy Policy and check that box.
- c. Then check the "affiliated with URI" box that pops up and click "Continue..."
- d. Complete the registration process with your name, email and password and continue with organization questions.
- 3. Once you have completed registering and/or logged in, you will arrive at a page titled "institutional courses". Click on

URI's "View Courses" button.

- 4. Click on Courses Ready to Begin "Learner Tools".
- 5. Click on "Add a Course", which takes you to "Select Curriculum".
- 6. Ignore all the text on this page, scroll down to the bottom and click on "Continue to Question 1 at this time."
- 7. Ignore questions 1-8 and scroll down to Question 9, Export Compliance.
- 8. Select "CITI Export Controls Course" and hit the "Submit" button.
- 9. This will bring you to the welcome page. It should say something like "you are now enrolled..."
- 10. Go to bottom of screen and click "Add Courses."
- 11. That will take you to the list of export control modules. The required module is #9 "Introduction to Export Compliance".
- 12. Select the Introduction Course and hit "start" to commence taking a module.
